# Training on Climate Change Adaptation and Mitigation targeting smallholder farming communities


This training course is the second of a series of three courses organized by the International Institute of Rural Reconstruction to facilitate community-level climate change work. It focuses on food security and natural resources management.

# "Row Erupts over Jamaica's Bid to slow Beach Erosion"



Communities in Negril, Jamaica, are divided between those for and against the construction of concrete breakwaters in order to stop beach erosion. Those opposed to the structures fear they will hinder the natural regeneration of the beach after extreme weather events and damage the tourism industry. Previous plans had included a comprehensive ecosystem upgrade to include "softer" engineering approaches, also endorsed by UNEP which conducted the Risk and Vulnerability Assessment Methodology Development Programme (RiVAMP) in 2010 in Negril. The UNEP study revealed that coral reefs and seagrasses provided up to 40% natural protection of the beach and recommended that human induced drivers coastal ecosystem degradation, including land-based pollution, illegal beach mining and sea-grass removal, need to be tackled. Supported by the UNDP and Australian Aid, the proposed policy document was released for public consultation on 30 January. Ecosystem-based approaches are being defined as one of the strategic priorities, such as budgeting the value and benefits of ecosystem services and developing educational programs on the value of ecosystem-based adaptation.
