PEDRR Promotes the Role of Environment in DRR at the 4th Global Platform on Disaster Risk Reduction

(Geneva, Switzerland 19-23 May 2013) The biennial meeting once again brought together actors and stakeholders from the public and private sectors to discuss and share knowledge on advancements in the field of disaster risk management and climate change adaptation. This 4th session had a special focus on the economic losses from disasters and the importance of publicprivate partnerships (PPP) in reducing the costs of catastrophes.

PEDRR actively promoted ecosystem-based approaches as viable solutions to disaster risk mitigation, climate change adaptation (Eco-DRR-CCA) and resilience building through presentations and side events. The well-placed Marketplace booth and the Education and Community space allowed to showcase the Partnership's work in Eco-DRR-CCA, while promoting the launching of "The Role of Ecosystems in Disaster Risk Reduction" (UNU-Press) and the high-level panel discussion as well as the

side event on "Ecosystems, resilience and DRR" were a success. Social media platforms were also used as an advocacy tool during the conference.



As the gathering came to a close, the Partnership's efforts were rewarded as a delegate of the East African Community and the Head of the specialized group on environment and DRR of the Swiss Agency for Development and Cooperation both supported the reinforcement of the role of environment in the follow-up document to the Hyogo Framework for Action during the final plenary session summarizing key outcomes and messages of the conference.*
